ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.71 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.71 per Offer Share, the net proceeds from the Global Offering to be received by the Company after deducting the underwriting fees and commissions and estimated total expenses paid and payable by the Company in relation to the Global Offering, is estimated to be approximately HK\$77.6 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

Applications Under the Hong Kong Public Offering

- The Hong Kong Public Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 21,817 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 8,969,776,000 Hong Kong Public Offer Shares, equivalent to approximately 578.7 times of the total number of 15,500,000 Hong Kong Public Offer Shares initially available for subscription under the Hong Kong Public Offering. In accordance with the clawback mechanism as mentioned in the Prospectus, the final number of the Hong Kong Public Offer Shares is 77,500,000 Offer Shares, representing 50% of the total number of the Offer Shares available under the Global Offering.

International Placing

The final number of the Offer Shares under the International Placing is 77,500,000 Offer Shares after reallocation to the Hong Kong Public Offering, representing 50% of the total number of the Offer Shares initially available under the Global Offering. Before the said reallocation, the initial number of the Offer Shares under the International Placing is 139,500,000 Offer Shares. There are a total of 268 placees. A total of 121 placees have been allocated five board lots or less of Offer Shares, representing approximately 45% of the total number of placees under the International Placing.
